

17 of these children found homes in guardianships with relatives, allowing familial bonds to stay strong.

14 children found a secure new start through adoption.

40 children returned home to a safer, sober, loving, and healing family. CASAs have helped their parents begin again.

Overall, 158 people have had their lives and families positively impacted through the service of a CASA volunteer.

This year, we formed new relationships by holding two new public events. Our first was a special screening of the Award-winning documentary "Daughter of a Lost Bird," and the second was a live storytelling event, Change a Child's Story.



Both events brought members of our community together with CASA volunteers to build collective knowledge about how best to advocate for children and families in crisis.





## Our advocates gave 3,251 hours of service to abused and neglected children in our community this year.



We also expanded our training program to **5 preservice training sessions per year.** This new training schedule helps us appoint CASAs to children as soon as their case opens.

#### Change a Child's Story



CASA of Missoula knows how crucial it is to provide support for our volunteers outside of their casework, & to recognize their incredible gifts of service to our community.

In 2024, we saw outstanding attendance at our Volunteer Appreciation Party where CASAs, their families, and members of our child advocacy community came together to show gratitude for all they do.



We also meet with a volunteer leadership committee every month. Our Volunteer Voices committee helps CASA staff stay connected with the experiences and concerns of our volunteers.

Each year their recommendations help improve our program's activities.

Thanks to their insight, we have been able to deepen our understanding of the collaborative relationship between CASA volunteers and CFS social workers—an ongoing partnership we take very seriously.





#### SPOTLIGHT: MEG EDDY

One of our most cherished volunteers is Dr. Meg Eddy. She is the recipient of the 2024 Montana Children's Trust Fund Strengthening Families Award, and began service in April 2020.

With a Doctorate in Medicine and a BA in Biology, Meg uses her CASA role and medical background to educate every team she joins, working with the social worker and child's attorney to provide relevant recommendations. In some cases, this has resulted in educating parents about changing their behavior toward healthier relationships with their children.

"Her work has been invaluable. She's been resourceful, committed and communicative. I appreciate her dedication to this particular child, as well, because they are outside Missoula and it's so helpful to have Meg be able to meet with them frequently, as that's more of a challenge for me. She's been great to work with thus far and I hope to have more cases with her in the future!"
